## National Leaders Enthuse Attendees at "Best Care Practices in the Geriatrics Continuum 2012"

- Annual conference marks another active year for Florida Medical Directors Association

West Palm Beach, Fla. — Florida Medical Directors Association (FMDA) recently hosted its 21<sup>st</sup> annual conference which gathered more than 300 long-term care (LTC) practitioners and industry representatives at Walt Disney World's Dolphin Hotel in Lake Buena Vista, Fla.

The conference was very well attended and its success resonated throughout attendees and exhibitors who were present. The focus of this year's educational programming was on acute emergencies in the long-term care setting. Aside from learning in the classroom, attendees were given a chance to network with their peers and to meet with more than 30 exhibitors during the annual trade show.

A featured session of the conference included the annual national leaders' forum which focused on future directions and forging new partnerships in long-term care and geriatrics. On hand to represent the American Medical Directors Association (AMDA) was its president, Dr. Matthew Wayne. The National Association Directors of Nursing Administration (NADONA) was represented by its president, Robin Arnicar, and able to join us by video, from the Centers for Medicare and Medicaid in Baltimore, MD, Dr. Alice Bonner. Each leader offered insightful perspective into their respective organizations and looked closely at upcoming challenges that are faced by practitioners working in the industry. The leaders spent a large portion of their time answering difficult questions from the audience on the most pressing issues, while FMDA President Dr. John Symeonides served as moderator.

Her case, as portrayed in her poster presentation, dealt with the examination of an 82 year-old with Tinnitus, a pre-cursor to Neurosyphilis. The Study category recognized two winners. In 2<sup>nd</sup> place was Dr. Sweta Tewary, a Project Coordinator from Nova Southeastern University, with a poster examining foot problems in nursing homes. The 1<sup>st</sup> place winner in the Study category was Dr. Simone Minto-Pennant, a pharmacist at VA Medical Center in Orlando. Her study focused on medication error reporting in long-term care.

Plans for FMDA's 22<sup>nd</sup> annual conference are already underway. Best Care Practices in the Geriatrics Continuum 2013 will be returning to *Disney's Contemporary* Resort, October 17-20, 2013.
