I am writing to update you on some recent legislative activity in your state. The following bills have been introduced or amended during the new 2008 legislative session:

**SUMMARY:** (Memorial) Urges the Congress of the United States to increase federal financial assistance for home health services for elderly patients when it is determined that a patient is in need of such services. Urges the Congress to establish federal guideline requirements for students and schools that train certified nurse assistants and home health aides.
