The educational program is designed to provide a review and update of major geriatric diseases, illnesses, and risks found in nursing home patients, residents of assisted living facilities, and seniors living at home. Topics include the clinical relevance of advanced wound healing techniques; a lecture on dementias; depression and mood disorders in the elderly with a focus on assessment and treatments; annual update with National Leadership Council featuring American Medical Directors Association (AMDA) President David Brechtelsbauer, MD, CMD; American Society of Consultant Pharmacists (ASCP) President Judith L. Beizer, College of Pharmacy & Allied Healthcare Professionals, St. John's University, Jamaica, NY; and Gerontological Advanced Practice Nurses Association (GAPNA) President Patricia Kappas-Larson, MPH, APN-C, FAAN; AHCA nursing home regulatory update; chronic pain management overview; separate sessions that include the latest treatments for diabetes, movement disorders, geriatric ophthalmology; and a look at the state of improving nursing home care by reducing potentially avoidable hospitalizations.

Best Care Practices is the annual conference which is jointly-sponsored by the Florida Medical Directors Association and the American Medical Directors Association in conjunction with the Florida Chapter of the American Society of Consultant Pharmacists, and in collaboration with the American College of Health Care Administrators, American Association for Long Term Care Nursing, and the Florida Geriatrics Society.

Target Audience

This conference is designed to educate physicians, physician assistants, nurse practitioners, directors of nursing in LTC, registered nurses, senior care pharmacists, consultant pharmacists, and long-term care administrators, as well as geriatricians, primary care and home care physicians, physicians considering becoming long-term care or home care medical directors, and others with an interest in geriatrics and its continuum of care. The faculty includes national and regional authorities in the fields of medical direction, senior care pharmacology, as well as long-term care and geriatric medicine.

Pre-Conference Programming

The conference starts on Thursday, Oct. 29, 2009 with two pre-conference tracks: Firstly, the American Medical Directors Association will be hosting a daylong "Clinical Practice Guidelines Train the Trainer Implementation Workshop" focusing on pain management and its related F-tag. Secondly, all three Florida Mandatory Licensure Renewal Courses will be offered.

Cutting Edge Lectures and Scientific Poster Presentations

Other unique features about this year's conference include a Medicare Billing Workshop with AMDA Past-President Dr. Dennis Stone and FMDA hosting its sixth annual scientific poster.

Poster sessions provide an opportunity for practicing physicians, pharmacists, and nurse practitioners to share with colleagues the results of research, best practices, and outcomes. The sessions are visual presentations using diagrams, charts, and figures. Poster presentations may be on any aspect of the following categories and all poster abstract proposals must be submitted online via our website at www.fmda.org. All submissions that are complete and follow the Criteria for Acceptance of Posters will be considered and reviewed based on the content contained within the proposal.
